Agreement for Wholesale Purchaser with Teaching License

AoR agrees to sell resources it produces to Wholesale Purchaser with a Teaching License at wholesale prices subject to the following provisions:

1. For Wholesale Purchasers in the United States: Wholesale Purchaser agrees to pay in advance of purchase, by check or credit card, for the *first order*. Once credit has been approved by AoR, subsequent purchases may be made on account. Subsequent purchases will be invoiced upon order and sent with the materials, or upon request, separately to a “Bill To” or “Ship To” address. Payment in full by check or credit card is due within 30 days of date of invoice. No additional purchases on credit will be extended to past due accounts unless satisfactory arrangements are made with our Accounting Department. Any payments due past 30 days shall incur interest at the rate of 1-1/2 percent per month (18% per annum) until paid in full.
2. For Wholesale Purchasers outside the United States: Wholesale Purchaser agrees to pay by credit card at the time of order. Credit card purchases will automatically calculate exchange rates and provide payment to AoR in US dollars. Any other arrangements for payment must be made in US Dollars and approved by AoR in advance of shipping materials.
3. AoR may withhold any shipments when credit card charges are not approved or if checks are rejected for insufficient funds by the bank. Whether or not shipment of resources has been made, Wholesale Purchaser agrees to reimburse AoR for any charges incurred in depositing bad checks or collecting funds for non-approved credit card charges.
4. Wholesale Purchaser is responsible for shipping and handling charges. Such charges will be determined at the time of shipment.
5. Most orders will be filled within three business days. However, large orders may take a week to fill before being shipped. AoR shall notify Wholesale Purchaser if any shipments will be delayed more than 5 business days due to backordering, holidays, or other special conditions.
6. Rush shipping services may be available upon request for additional shipping and handling fees.
7. AoR products available and wholesale prices are identified on the attached AoR Products Wholesale Purchase List and subject to change without notice. **Wholesale Purchase prices DO NOT APPLY to the purchase of *Conflict Resolution vs. Reconciliation* seminar guides, which include a license fee.**
8. AoR products sold at wholesale prices may or may not be pre-packaged, sorted, or shrink-wrapped, such as 10 packs of *Proclaiming God’s Forgiveness* pamphlets. If specific packaging is requested, additional charges may be incurred by Wholesale Purchaser for materials and labor.
9. Products not listed on the attached AoR Products Wholesale Purchase List, especially those requiring licensing and/or program oversight by Ambassadors of Reconciliation (e.g., seminar guides), will not be made available for resale to Wholesale Purchaser except by special permission.
10. Wholesale Purchaser agrees not to sell AoR products below the suggested retail price without written permission from AoR. Nevertheless, AoR expects that a Wholesale Purchaser outside the United States will need to make adjustments necessary for exchange rates and higher shipping costs when establishing retail sales prices.
11. Wholesale Purchaser may advertise AoR products in its seminars, flyers, catalogues, web-based advertisements, and other media to market AoR products. Wholesale Purchaser has permission to photograph covers of AoR

products or copy AoR web site pictures of products to use in its marketing efforts. AoR may provide Wholesale Purchaser with digital images of AoR products upon request, and Wholesale Purchaser agrees to pay for any special costs incurred by AoR to provide such images.

12. 180-Day Limited Warranty: AoR warrants that the products it sells to Wholesale Purchaser will be free of defects that would prevent the normal use of the product or AoR will refund the purchase price of the product or replace the defected product, as determined by AoR. This limited warranty is good for 180 days from date of purchase from AoR.
13. AoR is not responsible for products damaged in shipping. Items damaged by shipping are the responsibility of the shipping entity, and any claims for shipping damage must be made with the shipping entity. Wholesale Purchaser may purchase at its own expense shipping insurance if offered by the shipping entity.
14. Provisions for Returning Purchased Products:
 - a. Returns must be pre-approved by phone, letter, or email.
 - b. Returns must be within 60 days of original date of delivery date.
 - c. Returned product must arrive at AoR's office in resalable condition; products that are damaged will be non-refundable or discounted accordingly.
 - d. Returned products may be subject to a 15% restocking fee.
 - e. Wholesale Purchaser is responsible for all shipping charges involved for returning products.
15. **Wholesale Purchaser may not state or infer it is a representative of AoR under any circumstances, including when selling or distributing AoR Products; and Wholesale Purchaser shall not use the AoR logo and name as its own name.** However, Wholesale Purchaser may use AoR logo and name to describe the products it is selling (e.g., "We sell resources produced by Ambassadors of Reconciliation.") AoR reserves the right to regulate the use of its name and logo for any purpose.
16. This agreement does not give the Wholesale Purchaser an exclusive right to sell AoR products in any particular area or territory. AoR reserves the right to sell its products to anyone in any area or territory, including to any other Wholesale Purchaser.
17. AoR may amend any of the terms of this agreement at any time with a fourteen (14) day notice. Because AoR does not control all the costs for producing its products, wholesale prices may change at any time without notice, although AoR will endeavor to provide a fourteen (14) day notice when possible.
18. This Agreement for Wholesale Purchaser with Teaching License terminates when the Teaching License terminates. Furthermore, AoR may terminate any agreement to sell resources to a Wholesale Purchaser on a wholesale basis if discontinuing such an arrangement is in the best interests of AoR. AoR may terminate such agreement without any advance notice. However, AoR will normally provide a fourteen (14) day notice by mail or email, unless AoR determines that it needs to take more immediate action.
19. Christian Conciliation Clause: Any claim or dispute arising from or related to this agreement shall be settled by mediation and, if necessary, legally binding arbitration in accordance with the Rules of Procedure for Christian Conciliation of the Institute for Christian Conciliation (complete text of the Rules is available from ICCPeace.com). Judgment upon an arbitration decision may be entered in any court otherwise having jurisdiction. The parties understand that these methods shall be the sole remedy for any controversy or claim arising out of this agreement and expressly waive their right to file a lawsuit in any civil court against one another for such disputes, except to enforce an arbitration decision.
